The concern for campus security, drug abuse, and sexual violence is a national concern. As a part of the Federal Government's efforts, we comply with the Student Right-to-Know and Campus Security and Drug-Free Schools and Communities Acts by providing this annual document for your information and use. This document also contains information regarding the Seminary's policy related to the Clery Act and the SaVE Act as well as the Seminary's Fire Safety Report.

Asbury Theological Seminary's Emergency Alert Response System (EARS) provides critical alerts for our main campus and all instructional sites via text message, email, and voice calls in emergency situations and for other important safety-related announcements.

Other resources are available through several community agencies that are beneficial in this effort. If you desire further information, please contact the Student Life Office on the Seminary's Kentucky Campus.

Student Right-to-Know and Campus Security Act

When a crime has occurred, or is believed to be occurring, local law enforcement should be contacted as quickly as possible at 911. After first contacting emergency personnel and ensuring the emergency is under their control and oversight, students and employees should then file an incident report about any criminal action or emergency here: https://connect.asburyseminary.edu/facilities/incident-report-form/. Please include in the report the date and time, location, type of crime, persons involved, and relationship of persons involved. Students residing in residence halls or family housing should also report this information to their Resident Assistant or Resident Host.

Entrances to all campus buildings are locked after the conclusion of classes and other events each day. All exterior entrance doors to single student residence halls are equipped with electronic locks (accessed by the student's ID card) and remain locked 24/7. A security worker makes rounds of other buildings during non-business hours seven days/week.

An on-call maintenance worker is available to respond to any maintenance emergency and may enter any building for which an emergency seems evident. To report a maintenance emergency, residents should call 859.858.2298 from 8:00am-4:00pm on business days and 859.297.8577 outside of these times. For emergency situations in residence halls or family housing units owned by the Seminary, residents should contact their assigned Resident Assistant or Resident Host 24/7, but only after 911 has been contacted when local law enforcement authorities, fire department personnel, or medical personnel may be needed.

Campus security workers are under the supervision of Mr. Torrance Clark, Director of Facilities & Security, on the Kentucky Campus. Security staff are responsible for locking buildings and reporting security/emergency situations. They do not have authority to arrest individuals; they may call for local/state law enforcement, fire safety personnel, or medical personnel as the situation warrants.

Also, campus security features, such as lighting, signage, and security cameras receive attention from security personnel, maintenance, and IT personnel as appropriate.

Drug-Free Schools and Communities Act

Standards of Conduct

The Seminary's standard of conduct and Ethos Statement prohibit the unlawful possession, use or distribution of illicit drugs and alcohol by students and employees on Seminary property or as part of any Seminary activity. Students should refer to the most recent version of the Student Handbook at: http://asburyseminary.edu/students/student-services/student-handbook/ for a complete statement of conduct standards.

Legal Sanctions

The following paragraphs describe the local, state, or federal legal sanctions for the unlawful possession or distribution of illicit drugs and alcohol:

Kentucky Revised Statutes 218A describes the legal consequences for the individual who unlawfully and knowingly traffics, sells, manufactures, possesses, plants, cultivates, or harvests any controlled substance or illegal drug. Click here for KRS 218A

Kentucky Revised Statutes 242.230 describes the legal consequences for the individual who unlawfully possesses any alcoholic beverage. <u>Click here for KRS 242.230</u>

A brief description of Federal laws pertaining to this act is available upon request in the Office of Student Life.

Health Risks

The health risk associated with the misuse and abuse of illicit drugs and alcohol include but are not limited to physical and psychological dependence; damage to the brain, pancreas, kidneys and lungs; high blood pressure, heart attacks and strokes; ulcers; birth defects; a diminished immune system; and death.

Educational Program

The individual who chooses to use illicit drugs or alcohol has made a conscious choice to jeopardize the well-being of their own life as well as the lives of others in the community and its ethos. Therefore, Asbury Theological Seminary provides the following opportunities for each student to address the issue:

- Each student has access to a current copy of the Student Handbook at: http://asburyseminary.edu/students/student-services/student-handbook/
 The handbook provides the following response to serious violations: "In the case of serious problems involving a student's personality or character, he/she may be required to postpone studies for a period of time in order to deal with problems. In severe cases a student may be dismissed from the Seminary."
- 2. Any student who voluntarily approaches the counseling center and seeks counseling for involvement with illicit drugs and alcohol will receive confidential counseling. This could result in more extensive counseling or other professional treatment as determined by the counselor.
- The issues regarding the involvement with illicit drugs and alcohol will be explored by the distribution of appropriate materials and information seminars throughout the year as needed. Faculty and staff should refer to the appropriate manuals for policies under which they were hired.

Penalties for Violations of Policy

As described above, any student who sells, purchases, produces, possesses or consumes alcoholic beverages (on seminary property) or any illegal drug is subject to disciplinary action. If a person is suspended, specific rehabilitative guidelines for re-admission will be given to the student and appropriate follow-up will determine when the student will be allowed to return.
